

RESOLUTION NO. 16-2016

A RESOLUTION DECLARING RICHFIELD JOINT RECREATION DISTRICT PROPERTY AS SURPLUS PROPERTY NO LONGER NEEDED FOR PUBLIC USE, OBSOLETE, OR UNFIT FOR THE USE FOR WHICH IT WAS ACQUIRED, AND AUTHORIZING THE DISTRICT TO SELL SAID PROPERTY

WHEREAS, the Richfield Joint Recreation District is in possession of personal property, including motor vehicles, and other personal property and equipment, which is no longer needed for public use, or is obsolete, or is unfit for the use for which it was acquired; and

WHEREAS, this Board has created an Inventory attached as "Exhibit A" and has determined that specified District property listed on "Exhibit A" is no longer needed for public use, is obsolete, or is unfit for the use for which it was acquired, and, thus, is surplus property; and

WHEREAS, this Board desires to sell said surplus property, by internet auction, public auction or private sale; and

WHEREAS, this Board wishes to authorize the Administrator or her designee to advertise in a newspaper of general circulation this Board's intent to sell unneeded, obsolete, or unfit District personal property by internet auction or otherwise; and

WHEREAS, this Council further wishes to authorize the Administrator or her designee to post notice of the intent to sell unneeded, obsolete, or unfit District personal property on the District's website throughout the year.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Richfield Joint Recreation District, Summit County, State of Ohio:

- SECTION 1.** That the specified personal property of the Richfield Joint Recreation District listed in "Exhibit A" attached hereto is hereby declared as being no longer needed for public use, obsolete, or unfit for the use for which it was acquired, and is thus surplus property.
- SECTION 2.** That said personal property listed in "Exhibit A" hereto, unless marked to retained as RJRD Inventory shall be sold by internet auction, public auction, salvage/scrap, or private sale. Property listed in Exhibit A that has no resale value or cannot be sold may be discarded, donated to public agency or non-profit charitable organization.
- SECTION 3.** It is found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution shall take effect and be in force from and after the earliest period allowed by law.


