Call to Order: The Board met in person in Council chambers at Richfield Village Hall. The meeting was called to order at 6:30 p.m. by Anita Gantner, Board Chair.

Approval of Minutes

Standing Committee Reports

Governance: Mr. Lyons reported that a meeting of the governance committee is scheduled for June 14. The topics will include RJRD Board bylaws and the Oviatt House work agreement.

Grants & Fundraising: No meeting and no report.

Administration Report:

Park Director John Piepsny announced that Maintenance Technician Chris Moore passed the first of his invasive species tests, allowing him to supervise the chemical treatment of invasive species in the parking lots and paved areas. He will take the second test for wooded area invasive species treatment soon.

Mr. Piepsny also stated that, since the park is now much busier on weekends than it used to be, the Saturday morning volunteer group will check trash and latrines while they are here, in addition to the cleaning of latrines and emptying of trash on Wednesdays by the TLC crew.

Treasurer Report:

Mr. Wehner reported the following numbers for May:

About \$737,000 in the bank, with about \$165,000 in outstanding checks, for a balance of \$570,000. Of this, \$248,000 is restricted for the bond retirement fund, leaving about \$320,000.

Receipts this month were \$9,500 for the brush hog, and about \$10,000 from The Lodge. Expenses were standard for the month, plus the bond payment..
