

Special Meeting with Work Session July 6, 2020

Call to Order: The Board met virtually due to the COVID-19 Pandemic per House Bill 197. The meeting was called to order at 6:32 p.m. by Bob Becker, Board Chairperson.

Work Session

Gund Hall Tables / Chairs:

Ms. Apidone requested increasing the purchase order for tables and chairs needed to rent Gund Hall from the original \$8,800 to \$9,300 to cover increased costs of shipping.

Insurance:

Ms. McGinty presented the Ohio Plan insurance package up for renewal for \$11,062. She recommended that the policy be reviewed to make sure coverage is at the correct amounts. Mr. Gonzales questioned building valuations. Mr. Norris said building values had been decreased or increased on select buildings per the board's request. Board consensus was that the policy should be renewed as is but continued review is needed.

Camera System:

Mr. Deluca reported working with Bay Pointe Technologies on cameras and said that 52 cameras are up and an additional six will be installed. Systems have been upgraded with new cable and wiring. Internet connections have also been installed by Spectrum. Currently camera footage is stored for two weeks before it is written over. Footage can be downloaded for use. Bay Pointe has submitted a proposal for having camera footage stored in the cloud at a charge of \$12 per month per camera. Additional discussion included the need for more information to determine how cameras can be accessed without cloud storage and if the cloud system can be used on a trial basis.
