

Work Session & Regular Meeting

Monday, December 12, 2016

(Meeting Held at the Village of Richfield Town Hall, Council Chambers)

Call to Order:

The Work Session & Regular Meeting of the RJRD Board of Trustees was "Called to Order" at 6:30 p.m. by Chairperson Mr. Cugini. Following the Pledge of Allegiance, Roll Call was taken by the Administrator.

Work Session:

Revenue Advisory Group:

Mr. Norris provided an overview of his recommendation that was sent to the full board as part of their agenda package. In response to discussion, Norris stated that the group would be "free form and members would cycle in and out on an as-needed basis." Norris stated that the group would utilize as many as eight (8) contributors, depending on the topic at hand and that they would likely meet more often than the governance committee. Norris would chair the advisory group and would report through the Governance Committee.

Fish Relocation & Lower Lake:

Before making any final decisions, it was determined that more assessments were required on the lower lake and dam. The next step is a hydrologic and hydraulic study [H&H]. This would not require the lowering of the lake. This was for first discussion with formal action anticipated at the next regular meeting.

Trustee Becker strongly recommended that the lake be lowered to prevent freeze and thaw on the concrete. It was also stated that the lake valve is not operational. This could be a good time to completely lower the lake to assess the problem. Lowering the lake would require fish relocation. River Reach Construction was contacted to provide a quote for lowering the lake and overseeing the assessment of the lake valve. Becker stated that he has not made an inspection of the valve and posited that it could be off the track or an issue with the screw. A letter of agreement was received and reviewed by Legal Counsel from the Metro Parks regarding the removal and relocation of the fish. Metro Parks would catch the fish and relocate them to a Metro Park lake in exchange for the fish.

2017 Education, Recreation, Preservation and Conservation Programs:

Trustee Clark presented an overview of the possible 2017 programs for the district and respectfully requested that the tentative list of programs be considered and first discussion waived so formal action could take place during regular business citing the positive discussion held with Richfield Township for a winter festival. The Park Services Committee recommended the list of programs with a vote by the committee 2/3.
