

RESOLUTION NO. 21-2017

A RESOLUTION AUTHORIZING THE RICHFIELD JOINT RECREATION DISTRICT TO ACCEPT THE SUPERIOR OF TWO BIDS FOR SECURITY CAMERAS AND RELATED EQUIPMENT FOR RICHFIELD HERITAGE PRESERVE

WHEREAS, Richfield Heritage Preserve (the "Park") continues to experience significant damage from vandals, who have broken windows and doors in many of the Park's buildings, discharged weapons at the Park and thrown picnic tables into the upper lake; and

WHEREAS, several of the Trustees, including Messrs. Becker, DeLuca, Norris and Smith, have devoted considerable time and effort over a period of several weeks to meet with security consultants, security equipment specialists and sales professionals and to solicit written bids for security equipment (including cameras, monitoring and recording equipment and related hardware, together with the software required for their operation and consulting and related services for the installation and initial operation of such equipment), and to evaluating the two comparable written bids (copies of which are attached to this resolution) that we have received and the firms which issued them; and

WHEREAS, the Trustees who have participated in these evaluations have concluded that (a) the purchase and installation of a security system, including cameras with recording and monitoring features, is, given the scope and consequences of the vandalism that the Park continues to suffer, an emergency public safety issue, and (b) that seeking additional bids is unlikely to yield results superior to those which are set forth in the bids received to date.

BE IT RESOLVED by the Board of Trustees of the Richfield Joint Recreation District, County of Summit, State of Ohio:

SECTION 1. That the Chairman of the Board of Trustees or any Board member designated by the Chairman be authorized to negotiate with the party which presented the superior bid for security cameras and related equipment (to be determined in the reasonable judgment of the Chairman of the Park Operations Committee, in consultation with such other Board members as such Chairman may choose to consult, on the basis of his and their evaluation of the bids and the bidders), to the end of reaching agreement for the prompt acquisition and installation of the security equipment required for the protection of the Park and described in the attached bids.

SECTION 2. That this Board finds and determines that all formal actions of this Board concerning and relating to this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in those formal actions were in meetings open to the public in compliance with applicable law.

SECTION 3. That this Resolution shall be in full force and effect from and immediately upon its adoption.

By accepting the quote on the previous page customer agrees to the following sale terms and conditions.

Payment of Price The price quoted is payable in full prior to shipment unless customer has established a credit account with Bay Pointe Technology, Ltd (Bay Pointe). If customer has established a credit account with Bay Pointe the terms of credit are incorporated into these sale terms and conditions.

Sales Tax Sales tax will be added to the quoted price unless customer has provided a tax exempt certificate. Customer shall be responsible for any sales tax assessment which challenges customer's claimed exemption.

Delivery All products are sold FOB Bay Pointe. Customer is responsible for the shipping charges listed on the quote. Unless requested otherwise, delivery is made via five day ground delivery. Risk of loss shall remain with Bay Pointe until delivery of the product to customer. Bay Pointe shall have no liability for misdelivery or late delivery. Products damaged in transit will be repaired or replaced at no charge to customer.

Bay Pointe Warranty All products sold are warranted against defects in manufacture for 3 years from the date of shipment. Any product found to be defective shall be repaired or replaced by Bay Pointe free of charge upon return receipt of the original product and confirmation of the defect. If Bay Pointe is unable to repair or replace the product Bay Pointe will refund the purchase price. Customer must contact Bay Pointe for instructions on return shipping which will be at no cost to customer.

Manufacturer's Warranty Customer shall have the benefit of any manufacturer's warranty available for new products.

Order Cancellations Sales of specially configured products may not be cancelled. Cancellation of sales of stock products after delivery shall be at the discretion of Bay Pointe.
