This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that is immediately necessary in order to pay for the services rendered; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the Trustees appointed, it shall take effect immediately upon its passage and execution by the Chairperson; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

BACKGROUND INFORMATION

Resolution 2017 is being submitted for consideration for adoption at the December 11, 2017 Board of Trustee Meeting. An appropriation transfer of \$16,000 is being requested in the General Fund to cover the increase in the insurance premium of \$7,551 to \$10,825, the purchase of a computer \$2,545, electric costs of \$400, and any other miscellaneous expense that may occur before year's end. Monies are being transferred from the part-time personnel and fringe benefit accounts that are not anticipated to be needed.

CONSIDERATIONS
