1. Amendment to PSAs (Purchase and Sales Agreements): Discussion and action regarding a Third Amendment to the Clean Ohio and Non-Clean Ohio Properties impacted by the Clean Ohio Grant Process and other related items:

The Board of RJRD Trustees discussed the extensions to the various dates and deadlines of the purchase and sales agreements for the Crowell-Hilaka property. The properties were split into two areas: Clean Ohio Grant and the Non-Clean Ohio. Legal Counsel stated that the dates and deadlines have been discussed with WRLC.

The Contingency Period would be extended until April 20, 2015, the Subdivision Period until April 15, 2015, Finance Contingency Period until April 30, 2015, Closing Date on the Non Clean Ohio Property on May 5, 2015 and Closing on the Clean Ohio Property on June 1, 2015.
