- B. Bidders are hereby notified that they shall make any necessary adjustments in their estimates as a result of this Amendment. It will be construed that each bidder's proposal is submitted with full knowledge of all modifications and supplemental data specified herein.

C. 1. Modifications and Clarifications:

Except as described below, the original bid document remains unchanged. The bid documents are modified and/or clarified, as follows:

- Section 00410 Bid Form: On Table 2 Unit Price Bid of Article 4.01, Item No. 5. "Coarse Aggregate No. 8" should read Item No 5. "Coarse Aggregate No 57".
- Section 00410 Bid Form: On Table 2 Unit Price Bid of Article 4.01, Assumed Quantity of Item No. 11 Type 3 Concrete C.I.P. Reinforced Concrete Walls should read "41" Cubic Yards.
- 3. <u>Section 02374 GEOWEB® Cellular Confinement System:</u> In Article 2.06.A and 3.02.F.1 the reference to coarse aggregate "No. 8" *should read* "No. 57".
- 4. <u>Section 00410 Bid Form, Article 3.01A:</u> Bidder must also sign the amendment and submit it with their bids.

C.2. Answers to Questions:

- 1. Q. Confirm Estimate
 - a. Engineer's Opinion of Probable Construction Cost = \$574,000
- 2. Q. Permitting Documents to be made available prior to construction?
 - a. USACE PCN will be provided prior to initiation of construction

- Q. Alternatives to metal steps?
 - a. Contractors may propose alternatives to the metal staircase. However, the PVC outlet pipe from the valve box and the existing bearing plate along the building must remain accessible.
- 4. Q. Confirm cut-fill.
 - a. Based on the Opinion of Probable Construction Cost there will be a net cut of approximately 570 CY.
- 5. Q. Confirm owner/engineer is responsible for hiring independent lab and completing compaction testing.
 - a. All lab testing, including proctor testing in advance of fill placement, shall be completed at an independent lab selected by the Owner.
 - b. Pursuant to Specification 02323, Section 3.03.I. Owner/Engineer shall perform compaction testing on soils prior to use as fill and, upon placement and compaction, the Engineer will determine the in-place moisture and field dry density.
- 6. Q. Tree clearing restrictions due to endangered species?
 - a. Per the U.S. Fish and Wildlife Service Ohio Ecological Services Field Office letter dated July 10, 2018 (included in Appendix D of the USACE 404, Pre-Construction Notification) "There are no critical habitats within your project area under this office's jurisdiction."
